#### **ABOUT US**

The purpose of the Eden Chamber of Commerce is to provide a single voice for all commercial interests within the Eden district, to actively promote business growth and excellence and to foster good relations with the local community. The Chamber aims to bring all local businesses together, develop new initiatives to help business owners build their business, provide educational opportunities, engage inspirational speakers and provide platforms for developing new skills.

#### ABOUT THE PROJECT

In February this year the Eden Chamber of Commerce Executive & Committee announced their success in obtaining funding through the Black Summer Bushfire Recovery Grant Program. This funding allowed for 4 containers to house hospitality businesses within the Snug wharf area in Eden. These containers will be **fully fitted** out specifically for a Café, Take Away, Restaurant style and a fresh seafood vendor. Each container is also fitted with solar!

The Eden Chamber of Commerce are working towards a peak tourism timeline, and we plan to have them completed, delivered and installed late October 2022 – just in time for the summer school holidays and, of course, the main cruise ship visitation period.

The containers will be housed on the vacant area next to the public amenities block with ample customer parking available. Please refer to the site plan below showing the 4 containers (yellow circle). We have secured additional space to house 2 more containers in the future.

Placement in this area will be complimentary to the recently completed (and Award winning) Eden Welcome Centre and create a very social atmosphere with a 'quirky' feel.





### LET'S GET CREATIVE - EXPRESS YOUR INTEREST!

#### Café:

Ideally, we are picturing this operation to be open early mornings catering to the breakfast/lunch and coffee crowd and providing some 'healthier' options.

Possibilities could be E&B rolls, muesli cups, sandwiches, wraps, pies, salads, fresh juices. There is also the opportunity to add ice cream as this is a popular item that is asked for a lot at the wharf.

You will need to source your own coffee machine/supplier for this venture.

## Takeaway:

This operation provides the option to serve burgers, seafood and general take away items. We note that Fry Daze will continue its operation nearby so it would be ideal to not offer the same items as Fry Daze but an opportunity here to expand on the seafood offering whilst also selling additional takeaway items.

#### Fresh Seafood:

This outlet's focus is fresh local seafood (as much as possible) complimented by other Australian seafood items. Ideally, fresh locally caught fish, as well as oysters, crayfish, mussels etc.

We envisage these items being either sold cold for customers to take away and prepare themselves (i.e whole and filleted fish, refrigerated seafood items) as well as ready to eat items (i.e cooked prawns, cooked half crayfish with salad, oysters).

We note this container has a salamander included in the fit out to enable items such as Oysters Kilpatrick or Lobster Mornay to also be included in the offering. Ideally this outlet should ensure they are open when Southlands is closed (Sat/Sun/Mon) as well as additional days.

#### **Restaurant:**

This outlet is setup to enable restaurant style food items. The <u>options here are</u> <u>endless</u> and we are open to ideas on what would suit the area whilst also complimenting the offerings from the other shipping container outlets.

Ideally the offering would be different to what is already available at other outlets in town.

# **ADDITIONAL INFORMATION**

- We anticipate delivery of the fitted-out containers mid-October 2022, and we are working towards a trading start date of 01 December 2022.
- Trading hours: At this stage we are not aware of any limitations to trading hours under our licence agreement with Crown Land.
   We would anticipate the hospitality precinct will operate 7 days a week, with vendors working together to ensure hospitality services are not all closed on the same day.
  - There may opportunity to capture 'breakfast' for some vendors (Café & Takeaway for example). Ideally given the location, and particularly during peak tourism seasons and throughout the Cruise season, demand would present an "all-day" trade opportunity.
- Rent: We are currently finalising details on monthly rental costs for the containers - considering operating costs that the Chamber will be liable for including insurance and lease of space from Crown Land.
   We will advise all interested parties as soon as possible.
- Services: Each container will have its own electricity meter (noting that each container is also fitted with Solar to help reduce power costs for vendors).
   Vendors will be responsible for their own power usage costs. We are working with Bega Shire Council with respect to water/waste and will advise how costs will be determined.
  - Each container will also have their own bottle gas supply this cost is also the responsibility of the vendor.
- Aesthetic Appeal: Tables/seating for approx. forty people will form part of this fabulous new eatery precinct and each of the settings have "all weather" roofing.
  - We encourage, and are more than happy to discuss, "individualisation" of each container by way of installing signage and making it as bright and funky as possible to create a great vibe.
- Additional Storage Space: We have worked closely with Crown Land and Marine Infrastructure to include the onsite shed as part of our land lease. We are happy to discuss use of this space with vendors who may require additional cold storage space (vendor supplied appliances) and/or dry storage.
- Insurances and relevant food handling/safety: It is the responsibility of each vendor to ensure they have a minimum \$20million Public Liability Insurance and hold all relevant certification to operate, including a Workplace Health & Safety Plan.

- It is envisaged that the successful applicants will be notified by Friday 28th October 2022 (or early the following week).


